This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 9 (3 sections each in Bal Vatika I, II & III respectively) and total number of sections from classes I to XII shall be restricted to 49. The total sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed including Bal Vatika. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 ft dimensions and as per Appendix-V.
2	The height of concrete boundary wall appears to be less than 6 feet near the gallery the iron mash is fixed to differentiate the adjacent building. Hence the school is directed to construct 6 feet height concrete boundary wall in all sides and submit the videographic compliance within 3 months.
3	Ramp to access toilets are seen temporary. Hence the school is directed to construct permanent ramp with sufficient space and railings and submit the videographic compliance within 3 months.
4	As per IC report, the school has CWSN toilets 3 each for boys and girls however not a single CWSN toilet is seen in IC video. The school has provided another video link (https://youtu.be/L1yUX9PVUzM) covering boundary wall and the toilets. The school has shown normal toilets as CWSN toilets which do not have proper support system and the rooms are narrow and there is no room for a wheelchair/walker to navigate. Thus the school shall construct separate toilets for CWSN, boys and girls on every

	floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography.
5	The school shall upgrade the math lab as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
6	Composite lab does not have Physics section. safety features like exhaust fan, emergency exit are not seen in the Composite lab, Bio and Chemistry lab. All the labs have plastic stools which are a fire hazard, hence inappropriate. The school is directed to upgrade the labs as per SoP issued by the Board and submit videography.
7	The building safety certificate does not have validity period. The school is directed to obtain revised building safety certificate mentioning all the details and upload the same on SARAS portal within 3 months. (suggestive format is available with circular No.12/2022)
8	The water and sanitation certificate uploaded by the school is not issued by PHE department. The school has not uploaded the water sample test report. The school is directed to obtain water and sanitation certificate and test report and upload the same on SARAS portal within 3 months.
9	.IC has suggested that (I) the parking area should be earmarked separately for students, parents & staff. (ii) Emphasize greenery around the campus including developing garden. The school is directed to comply the observations of IC.
10	The school shall conduct training of its teachers with CoE Bangalore within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty

amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
